The public hearing on the proposed 2025 budget of the Town of Hammel was called to order by town Chairman Jim Livingston at 6:00 p.m. Tuesday, November 12, 2024 at the Hammel town hall. All board members were present. The Pledge of Allegiance was recited.

Residents to view as follows: Revenues- General Tax Levy \$213,748, Intergovernmental 188,718, Licenses and Permits, \$2,300, Public Charges for Services \$4111, Miscellaneous \$1,900, Cash Balance Applied \$936. Loan: 150,000. *Total Revenue and Cash of \$561,713.* Expenditures- General Government \$75,850 Public Safety \$23,380, Public Works \$207,750 Conservation & Development \$500, Capital Outlay \$66,000 Debt Service \$85,774, Other Financial Uses: \$100, Taylor County (dog licenses) \$1,450, Road Fund \$100,000 Machinery Fund \$0, Contingency Fund \$0– *Total Expenditures of \$560,824.*

These figures briefly discussed.

### **Town Board Meeting – Town of Hammel – November 12, 2024**

The town board meeting was called to order by Chairman Livingston at 6:07 p.m. following the special town meeting of the electors on Tuesday, November 12, 2024 at the Hammel town hall. All board members were present with the exception of Supervisor Dave Emmerich.

The minutes of the October 08, 2024 meeting were reviewed. Supervisor Zenner made a motion to approve the minutes. Chairman Livingston seconded the motion. Motion carried.

Open session: Nothing.

Update on road conditions. Brad reported that the roads are in good condition. Jim and Lori Livingston donated 100 loads of fill. County bills are all submitted for the year. Center Avenue: Looking at late summer or early fall to pulverize. There is \$40,000 in the budget for the pulverization.

Town pickup truck. It was cost the town approximately \$15,000 to update the truck. Chairman Livingston made a motion to approve the new truck with payment. Supervisor Zenner seconded the motion. Motion carried.

The board reviewed the 2025 proposed town budget that was discussed during the public hearing held earlier tonight. Chairman Livingston made a motion to approve the 2025 budget as follows: Revenues- General Tax Levy \$213,748, Intergovernmental 188,718, Licenses and Permits, \$2,300, Public Charges for Services \$4111, Miscellaneous \$1,900, Cash Balance Applied \$936. Loan: 150,000. *Total Revenue and Cash of \$561,713.* Expenditures- General Government \$75,850 Public Safety \$23,380, Public Works \$207,750 Conservation & Development \$500, Capital Outlay \$66,000 Debt Service \$85,774, Other Financial Uses: \$100, Taylor County (dog licenses) \$1,450, Road Fund \$100,000 Machinery Fund \$0, Contingency Fund \$0– *Total Expenditures of \$560,824.* Supervisor Zenner seconded the motion. Motion carried.

Recycling: Supervisor Zenner reported on the most recent recycle meeting.

Fire Department: Nothing to report, next meeting 12/18/2024.

The bills were reviewed. Chairman Livingston made a motion to pay the bills. Supervisor Zenner seconded the motion. Motion carried.
